I, Nannie Tyson

SEND GREETING:

WHEREAS, I, the said Nannie Tyson

in and by my certain promissory note in writing, of even date with these presents, am well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of Two thousand no/100 Dollars,

to be paid on or before the date when the 5th Series of the Installment Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if

I fall to pay said interest or to comply in all respects with the By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage), as provided in and by the said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I the said Nannie Tyson

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, to the said AMERICAN BUILDING AND LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me the said Nannie Tyson

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION

All that piece, parcel or lot of land situated, lying and being in Greenville Township, County and State aforesaid, and being lot No. 5, as shown on Plat of White City View, which said plat is recorded in R.M.C. Office for Greenville County in Plat Book E, page 116 and having the following metes and bounds, to-wit: Beginning at a stake on O'Neal Avenue, joint corners of lots Nos. 5 and 6 and running thence with O'Neal Avenue S. 79.47 W. 53.8 feet to a stake; thence S. 0.11 W. 150 feet to a stake; thence N. 8.17 E. 54 feet to a stake; thence N. 0.20 W. 150 feet to the beginning corner."
