with interest thereon from September 27, 1922 at the rate of 8% per cent. per annum to be  
computed and paid.

Until paid in full all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage): as in and by the said note, reference

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do  
grant, bargain, sell and release unto the said C.F. Putman, All that certain piece, parcel or lot of

land situate, lying and being in the County of Greenville, State of South Carolina, and  
being the Northern half of that certain lot of land this day conveyed to me by C.F. Putman  
The lot hereby conveyed by this mortgage being described as follows:  
Beginning at a stake on Buist Avenue common corner of lots No. 6 and 7 and running thence  
along joint line of lots No. 6 and 7, S. 9-45 W. one hundred and twenty-six and three-  
tenths (126.3) feet; thence S. 80-15 W. fifty (50) feet; thence along line parallel with  
first line one hundred twenty-six and three-tenths (126.3) feet to a point on Buist  
Avenue; thence along Buist Avenue S. 80-15 E. to the beginning corner.
