Dollars, to be paid Four years from date, with the privilege to anticipate payment at any time

with interest thereon date until paid at the rate of seven cent. per annum to be
computed and annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent on amount due besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage): as in and by the said note, reference
being thereunto had, as will more fully appear.

grant, bargain, sell and release unto the said W. Marion Pack, his heirs and assigns forever: All that tract

of land in the State and County aforesaid, beginning at an iron pin on road leading to the
residence of Mrs. Becknell and running thence N. 77-1/4 W. 4.15 chains to an iron pin; thence
N. 41 W. 9.30 chains to an iron pin; thence S. 44 W. 6.21 chains to an iron pin; thence S. 44
E. 21.17 chains to poplar tree; thence S. 27 W. 1.27 chains to stone om; thence S. 45 E. 24
links to Blackbush om; thence N. 37-3/4 E. 5.00 chains to pine om; thence N. 40-1/2 E. 2.33
chains to an iron pin; thence N. 40 W. 4.17 chains to an iron pin; thence N. 65-1/4 W. 2.50
