in and by *my* certain promissory note in writing, of even date with these presents *are* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of *Seventeen hundred <sup>no 180</sup>* Dollars, to be paid on or before the date when the *5th* Series of the *instalment*

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if *I*

fail to pay said interest or to comply in all respects with the By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage), as provided in and by the said note, reference being thereunto had, will more fully appear

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said AMERICAN BUILDING AND LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *me* the said *Jno. G. Mauney*,

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION

All that piece, parcel or lot in land in Greenville Township, Greenville County, South Carolina, about 2 1/2 miles north of the city of Greenville, known as *Sau Souci*, and being known and designated as lot No. 28 of Block A. as shown by plat made by *W. A. Adams* Engineer, and recorded in R. M. C. office for said County in Plat Book A. pages 396 and 397, and having the following courses and distances according to said plat: Beginning at a *pin* at the northeast corner of Gridley and Martin streets and running thence with Gridley street in a northerly direction 118 feet to a *pin* with *corner* with lot No. 27; thence with *lot* *27* *1/2* feet to a *pin*; joint corners *along* along western line of lot No. 27 *1/2* feet to a *pin* on Martin street; thence *along* along Martin street, N. 89 1/2 W. 57 feet to the beginning. *View* *and* *company*, conveyed to me by Mountain View and *company*, by deed dated September 2, 1912, recorded in book 29, page 450.
