Greenville County, State of South Carolina, known as Lot No. 46 on plat of property of H.B. Bates, recorded in Office of R.M.C. for said County in Plat Book F, page 32, and having the following courses and distances according to said plat:

Beginning at an iron pipe on the Northwest corner of Center and Bates Streets and running thence with Bates Street N. 55-40 W. 50 feet to corner of lot No. 44; thence with line of said lot N. 48-30 W. 142.5 feet to iron pin; thence S. 55-40 E. 50 feet to iron pin on Center Street; thence with Center Street S. 48-30 W. 142.5 feet to the beginning.
