WHEREAS, I, the said P. W. Lowry

in and by my certain promissory note in writing, of even date with these presents well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of Fifty Two Hundred and no/100 Dollars, to be paid on or before the date when the 7th Series of the

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if I

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said AMERICAN BUILDING AND LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to the said P. W. Lowry

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING

AND LOAN ASSOCIATION that piece, parcel or lot of land in Ward No. 2 of the City of

Greenville, Greenville Township, State and County aforesaid, known as Lot #56 on revised plat of property of E.S. Rowley, recorded in the Office of R.M.C. for Greenville County in Plat Book C, at page 97, and having the following courses and distances according to said plat: Beginning at an iron pin at the southwest corner of McGee Street and Turpin Avenue, and running thence with Turpin Avenue S. 80 W. 155 feet to a ten foot alley; thence with said alley S. 21-45 E. 51 feet to corner of lot #55; thence along line of said lot N. 80 E. 155 feet to McGee Street, thence with McGee Street N. 21-45 W. 51 feet to the beginning corner. This is the same lot of land conveyed to the said E.W. Carpenter by Sarah R. Warnamaker by her deed dated March 9th, 1922, and recorded in the R.M.C. Office for Greenville County in Vol. 76 at page 67, and the same lot conveyed to me the said P.W. Lowry by E.W. Carpenter, by his deed dated February 16th, 1923 not yet recorded.
