*five dollars* with interest thereon, from *the 1st day of April 1928*

with interest thereon, from *the 1st day of April 1928* at the rate of *8* per cent. per annum to be  
computed and paid *monthly* *at* *the* *rate* *of* *8* per cent. per annum to be  
paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *ten per cent*  
besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference  
being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do  
grant, bargain, sell and release unto the said *W. B. Granger*

All that certain piece, parcel or lot of land situate, lying and being in the County and  
State aforesaid on the Cedar Land Road, near the City of Greenville and more particular  
described as follows:  
Beginning at an iron pipe, corner of lot No. 5 of the subdivision of W.P. Nesbitt's  
property on the Cedar Land Road, and running N. 79-39 W. a distance of forty (40) feet;  
thence N. 10-44 E. a distance of one hundred fifty (150) feet; thence S. 79-30 E. a distance  
of forty (40) feet to joint line of lots Nos. 5 & 6; thence along said line of lot No. 5  
to the beginning corner, a distance of one hundred fifty (150) feet and being the same lot  
conveyed to me this day by Drefus Granger.
