until paid in full, all interest not paid when due to bear interest at the same rate as principal, and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note, to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage, said note further provides for an attorney's fee of *ten percent of the*  
*amount due thereon* states all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference

In Greenville County, State aforesaid. All that certain piece, parcel and lot of land situate,  
lying and being in Ward No. 6 of the City of Greenville, County and State aforesaid, and  
having the following metes and bounds, to-wit: Beginning on Green Avenue at the south corner  
of Mrs. Mattie McGee's lot and running thence with Green Avenue S. 42 feet to stake; thence  
in a westerly direction parallel with Mrs. Mattie McGee's line 138 feet more or less to a stake  
thence in a Northerly direction parallel with Green Avenue 42 feet, more or less to a  
stake on Mrs. Mattie McGee's line; thence with Mrs. Mattie McGee's line 138 feet, more or
