75 feet to iron pin corner of lot 3 on said plat. thence  
N. 74-15 E. 144 feet to iron pin. thence N. 42-08 W. 85  
feet to iron pin corner of lot 1; thence along line of  
lot 1, S. 74-10 W. 101.2 feet to the beginning corner  
on West street.
