

Togther with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining. PROVIDED ALWAYS, NEVERTHELESS, and it is the true intent and meaning of the parties to these Presents, that if J. V. P. the said mortgagor, shall well and truly pay, or cause to be paid, unto the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, its certain Attorney, successors or assigns, the said debt or sum of money aforesaid with interest thereon, if any shall be due, according to the true intent and meaning of the said Bond and Condition thereunder written, then this deed of bargain and sale shall cease, determine and be utterly null and void; otherwise, it shall remain

in full force and virtue. And it is agreed, by and between the said parties, that the said mortgagor and their Heirs, Executors or Administrators, shall and will insure the House and Buildings on said lot in the sum of not less than \$ 5000.00

their attorney or attorneys for them and in their name to execute and deliver proper titles to the purchaser or purchasers for the premises sold,

This power of attorney to remain in full force and to be irrevocable, either by us or our Heirs, Executors, and Administrators, until the debt above mentioned shall have been discharged.

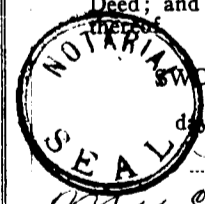
AND IT IS FURTHER AGREED, by and between the said parties, that the mortgagor shall hold and enjoy the said premises, until default of payment shall be made.
