ceedings of any kind, reference being hereunto had all more fully appear.

and released, and by these presents do grant, bargain, sell and release unto the said *Dora I. Snipes*

All that piece, parcel, tract or lot of land situated in *Greenville*  
Township, Greenville County, State of South Carolina,

*On the White Horse Road, known as a part of lot No. 33 on plat  
of property of Looper & Yorn made by R.E. Dalton, Engineer  
and recorded in Plat Book F. Page 77, and having the  
following metes and bounds: Beginning at a stake on  
the White Horse Road at its intersection with Gordon  
Street, and running thence with Gordon Street S. 79-45  
N. 150 feet to stake; thence S. 112N. 74.6 feet to stake; thence  
N. 79-45 E. 150 feet to stake in White Horse Road, thence  
with White Horse Road N. 11E. 74.6 feet to beginning corner.*
