of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:
WHEREAS, *I*, the said *A. B. Reid*
in and by *my* certain note or obligation, bearing date the *16th* day of *April* 192*4*
am indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate,
duly incorporated under the laws of such State), in the sum of *Fifteen hundred and no/100 (\$1500.00)* Dollars,
with interest thereon at the rate of eight per centum per annum, payable monthly, from the *16th* day of *April*, A. D. 192*4*,
according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that
I the said *A. B. Reid* shall pay or cause to be paid to the said
Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *April*
192*4*, and on the 20th or before the end of each month thereafter for twenty successive months the sum of
Twenty-five + no/100 (\$25.00) Dollars, *plus \$15.00* Dollars,
being the regular monthly installment payable on the *Fifteen (15)* shares of Stock, and *ten + no/100 (\$10.00)* Dollars,
being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the
sum of *Twenty-three + no/100 (\$23.00)* Dollars, (*\$15.00*)
Dollars, being the regular monthly payment on said stock and *Eight + no/100 (\$8.00)* Dollars, (being the monthly interest on balance due);
for the next twenty months the sum of *Twenty-One + no/100 (\$21.00)* Dollars, (*\$15.00*)
Dollars, being the regular monthly payment on said stock and *Six + no/100 (\$6.00)* Dollars, (being the monthly interest on balance due);
for the next twenty months pay the sum of *Seventeen + no/100 (\$17.00)* Dollars, (*\$15.00*)
Dollars, being the monthly payment on said shares of stock and *Two + no/100 (\$2.00)* Dollars, (being the monthly interest on balance due.)

hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and
Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In Greenville Township, being Lot No. 42 according to a plat recorded in Plat Book E, Page 249, R. M. C. Office for Greenville County, beginning on Heatherly Drive, corner of Lot No. 43; 128.1 feet from Cleveland line thence S. 36.15 N. 210 feet to corner of Lot 3; thence N. 53-45 N. 60 feet to corner lot 41; thence N. 36-15 E, 210 feet to Heatherly Drive; thence with Heatherly Drive S. 53-45 E. 60 feet to the beginning corner, and being the same plot conveyed to me by Pride + Patton Land Company by deed dated March 10th, 1924, and recorded in Volume 96, Page 5305 R.
