

### THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, Lee E. Porter  
 of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting  
 WHEREAS, I, the said Lee E. Porter  
 in and by my certain note or obligation, bearing date the 23rd day of August 1924  
am indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville in said State (a body corporate,  
 duly incorporated under the laws of such State), in the sum of Three thousand + 300/100 (\$3,000.00) Dollars,  
 with interest thereon at the rate of eight per centum per annum, payable monthly, from the 23rd day of August A. D. 1924,  
 according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that  
 the said Lee E. Porter shall pay or cause to be paid to the said  
 Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of July  
 1924, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Fifty + 00/100 (\$50.00)  
 Dollars, (\$3000.00) Dollars,  
 being the regular monthly installment payable on the Twenty (20) Shares of Stock, and Twenty + 00/100 (\$20.00)  
 Dollars, being the monthly interest on the advance or loan until there have been paid twenty monthly payments, and shall for the next twenty months pay the  
 sum of Forty-six + 00/100 (\$46.00) Dollars, (\$31.00)  
 Dollars, being the regular monthly payment on said stock and Seven + 00/100 (\$7.00) Dollars, being the monthly interest on balance due);  
 for the next twenty months the sum of Forty-two + 00/100 (\$42.00) Dollars,  
 (\$30.00) Dollars, being the regular monthly payment on said stock and Twelve + 00/100 (\$12.00)  
 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Forty-eight + 00/100 (\$48.00)  
 Dollars, (\$31.00) Dollars, being the regular monthly payment on said stock and Twelve + 00/100 (\$12.00)  
 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Thirty-four + 00/100 (\$34.00)  
 Dollars, (\$31.00) Dollars, being the regular monthly payment on said stock and Three + 00/100 (\$3.00)  
 Dollars, being the monthly interest on balance due.); for the next twenty months pay the sum of Thirty-four + 00/100 (\$34.00)  
 Dollars, (\$4.00) Dollars, being the regular monthly payment on said stock and Four + 00/100 (\$4.00)  
 Dollars, being the monthly interest on balance due.);  
 Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said Twenty (20)  
 shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made

 and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against me the said Lee E. Porter

in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the conditions thereunder written, reference being thereunto had will more fully appear.  
 NOW, KNOW ALL MEN, That I, the said Lee E. Porter  
 in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company,  
 according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me  
 the said Lee E. Porter  
 in hand well and lawfully paid by the said The Carolina Loan and Trust Company, at and before the signing and delivery of these presents, (the receipt whereof is  
 hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and
