SEND GREETING:

WHEREAS, I, the said H. L. Curry

in and by my certain promissory note in writing of even date with these presents also  
well and truly indebted to GREENVILLE BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in  
the full and just sum of Three Thousand (\$3,000.00)

DOLLARS,

to be paid on or before the date when the 35th series of the Capital Stock of the said GREENVILLE BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if I fail to pay said interest or to comply in all respects with the Constitution and By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being hereunto had, will more fully appear.

Curry in hand well and truly paid by the said GREENVILLE BUILDING AND LOAN ASSOCIATION at and before the date of these presents, the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said GREENVILLE BUILDING AND LOAN ASSOCIATION

(All That certain lot part of parcel of land situate lying and being in Tr. 5597 of Greenville County and State aforesaid, on the South side of Harrelly Street, and being known and designated as lot No. 14 as shown on plat recorded in Plat Book "E" at page 214, and having according to said plat the following metes and bounds to-wit:

Beginning at an iron pin on the South side of Harrelly street, joint corner of lots Nos. 13 and 14, running thence with the joint line of said lots S. 6-58 E. 142.8 feet to an iron pin in Bull's Alley; thence with Bull's Alley N. 87-43 W. 57 feet to iron pin, corner lot No. 15; thence with line of that lot N. 1-56 E. 140.1 feet to iron pin on Harrelly street; thence with Harrelly street S. 88-64 E. 316.5 feet to the point of beginning.
