SEND GREETING:

WHEREAS, *I*, the said *J. J. Ginn*

in and by *me* certain promissory note in writing, of even date with these presents, well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full

and just sum of *two hundred 70/100* Dollars,

to be paid on or before the date when the *21st* Series of the *Instalment*

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly, on or before Saturday night of each and every week, until paid in full; and if

*I* fail to pay said interest or to comply in all respects with the By-Laws of said association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage, as provided in and by the said note, reference being thereunto had, will more fully appear.

*J. J. Ginn* in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said AMERICAN BUILDING AND LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *me*

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING

AND LOAN ASSOCIATION all that lot of land in Greenville Township, Greenville County,

South Carolina, in Monaghan Annex and having the following metes and bounds, according to plat recorded in R.M.C. Office for said County in Plat Book C, page 63;

Beginning at a stake on the South side of Parker Road, corner of lot No. 43, and running thence with Parker Road 48 feet to a stake on Ohio Street; thence with Ohio Street 195 feet to corner of lot No. 44; thence with line of lot No. 44, ninety-four feet to corner of Lot No. 43; thence with line of lot No. 43, one hundred fifty feet to the beginning corner; being the same lot of land conveyed to J.F. Ginn by E. Inman, Master, by deed dated July 8th, 1926 and to be recorded.
