who may sue thereon and foreclose this mortgage; said note further providing for an attorney's

fees, besides all costs and expenses of collection, to be
added to the amount due on said note to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or
any part thereof, be collected by an attorney, or by legal proceedings of any kind of which is secured under this mortgage); as in and by the said note,

Beginning at an iron pin on the South side of said Avenue 378 feet from the South west corner of Townes Street and Park Avenue, and runs thence with said Avenue N. 76.30 W. 50 feet to the corner of lot of Webb and Henderson; thence with line of said lot S. 13.30 W. 146 feet, more or less, to the beginning corner. And being the same lot of land conveyed to me by B.O. Bentley 26, day of May, 1924.
