WHEREAS, I, the said Nettie J. Vaughan

in and by my certain promissory note in writing of even date with these presents am
well and truly indebted to GREENVILLE BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina,
in the full and just sum of Two thousand (\$2000.00)

DOLLARS,
to be paid on or before the date when the 12th series of the Capital Stock of the said GREENVILLE
BUILDING AND LOAN ASSOCIATION shall reach maturity with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or be-
fore Saturday night of each and every week until paid in full and if I fail to pay said interest or
to comply in all respects with the Constitution and By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and pay-
able, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said GREENVILLE BUILDING AND
LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me
the said mortgagor

in hand well and truly paid by the said GREENVILLE BUILDING AND LOAN ASSOCIATION at and before the signing of these presents, the receipt whereof
is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said GREENVILLE
BUILDING AND LOAN ASSOCIATION being known and designated as Lot No. 128 and that part

of lot No. 127 Block "G" adjoining Lot No. 128, on Ebaugh Avenue, as shown on plat recorded
in the office of the R.M.C. for Greenville County in Plat Book "A" at page 383, having a
frontage of 75 feet on Ebaugh Avenue and running back 175 feet: Beginning at a point
of Ebaugh Avenue, joint corner of lots No. 128 and 129, running thence with Ebaugh Avenue
N. 55.00 W. 75 feet which takes in half of lot No. 127 - to an iron pin; thence in a
parallel line with the line between lots No. 127 and 128, 175 feet; thence S. 55.00 E. 75
feet to corner lot No. 129; thence with line of lot No. 129 to Ebaugh Avenue, the point of
beginning 175 feet.
