SEND GREETING:

WHEREAS, I, the said H. V. Johnson

in and by my certain promissory note in writing of even date with these presents am
well and truly indebted to GREENVILLE BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina,
in the full and just sum of Four Thousand (\$4,000.00)

DOLLARS,

to be paid on or before the date when the 4th series of the Capital Stock of the said GREENVILLE BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if I fail to pay said interest or to comply in all respects with the Constitution and By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being hereunto had, will more fully appear.

Johnson in hand well and truly paid by the said GREENVILLE BUILDING AND LOAN ASSOCIATION at and before the signing of these presents, the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said GREENVILLE BUILDING AND LOAN ASSOCIATION all that certain piece, parcel or

lot of land situate, lying and being on Memminger Street, in the City of Greenville, State and County aforesaid, and known as lot no 9 on plat made by J. N. Southern, D. S. subdividing the property bought by Mountain City and Improvement Co., from Boscot & Browning, and having the following metes and bounds, to wit:
Beginning at the stake on corner of lot formerly owned by John Reynolds on Memminger St, and running thence with said street, S. 18 W. 43 feet to stake; thence N. 76 W. 204 feet to a ten foot alley thence with said alley N. 88 E. 43 feet to the line of John Reynolds lot thence with said line, S. 76 E. 204 feet to the beginning corner, containing 2/100 of an acre more or less.
