WHEREAS, *Oliver A. Peace*, the said

Three Thousand five Hundred (\$3500.00) DOLLARS,

to be paid on or before the date when the *2nd* Series of the Instalment Stock of the said THE PEOPLES BUILDING AND LOAN ASSOCIATION shall mature, with interest thereon from date at the rate of eight per cent. per annum, payable
