TO ALL WHOM THESE PRESENTS MAY CONCERN

of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, the said Robert Sample in and by my certain note or obligation, bearing the date 15th day of April 1925

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of said State), in the sum of Five Hundred Fifty Dollars

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 15th day of April A. D. 1925 according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following that is to say, that

the said Robert Sample shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of April 1925

and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Dollars, being the regular monthly installment payable on the 4 1/2 Shares of Stock, and Three + 20/100 (\$3.00)

Dollars, being the monthly interest on the advance or loan until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Dollars, being the regular monthly payment of said stock and Shares + 40/100 (\$2.40)

Dollars, being the monthly interest on balance due; for the next twenty months the sum of Dollars, being the regular monthly payment on said stock and One + 80/100 (\$1.80)

Dollars, being the monthly interest on balance due; for the next twenty months pay the sum of Dollars, being the monthly payment on said shares of stock and Dollars, being the monthly interest on balance due; for the next twenty months pay the sum of Dollars, being the monthly payment on said shares of stock and Dollars, being the monthly interest on balance due;

Each of the above payments to be made on the 20th or before the last day of each month shall thereafter surrender to the Company the said 7 1/2 shares of stock and the certificate thereof, the amount at such time paid shall be credited as a payment upon the advance or loan made

and shall pay or cause to be paid all fines which may be duly imposed upon or charged against the said Robert Sample in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the conditions thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That the said Robert Sample in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to

the said Robert Sample in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

the City of Greenville being Lot No. 5 of property of Cameron and Lower, according to plat made by R. C. Dallas recorded in Plat Book "C" page 222 of R. M. C. Office for Greenville County and having the following metes and bounds to wit: Beginning at an iron pin on the south side of Douthett Street corner of an eight (8) foot alley running thence with said alley S 20-20 W 42.4 feet to an iron pin thence with rear line of said alley S 70-58 E 4 feet to iron pin thence with line of lot No. 4 S 20-20 W 42.4 feet to an iron pin thence N 71-46 W 35 feet to iron pipe thence N 19-30 E 105 feet to iron pipe on Douthett Street thence with said Douthett Street S 70-58 E 32.5 feet to the beginning corner and being the same lot of land conveyed to me by J. C. Lower and W. P. Cameron by deed dated April 14th 1925, to be recorded.
