

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Mammie Green of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said Mammie Green in and by my certain note or obligation, bearing the 15th day of March 1926

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of fourteen hundred & no/100 (\$1400.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 15th day of March A. D. 1926,

according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I the said Mammie Green shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of April 1926, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of 23.33 Dollars, (14.00

Dollars, being the regular monthly installment payable on the 14 Shares of Stock, and 9.33 Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of 21.46 Dollars, (14.00

Dollars, being the regular monthly payment on said stock and 7.46 Dollars, being the monthly interest on balance due); for the next twenty months the sum of 19.60 Dollars, (14.00

Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of 17.73 Dollars, (14.00

Dollars, being the monthly payment on said shares of stock and 3.73 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of 15.86 Dollars, (14.00

monthly payment on said shares of stock and 1.86 Dollars, being the monthly interest on balance due.) Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said 14 shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made unto the said

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

Heard the City of Greenville and being known and designated as lots nos. 20, 21, and 22 of the J.R. West property and shown on plat of said property which said plat is recorded in plat book C page 190 R.M.C. office for Greenville County. Said lots have an aggregate frontage on an unnamed Street of 195.5 feet and a depth of 146.5 feet, more or less, and have such metes and bounds, courses and distances as shown by said plat and are three of the lots conveyed to me by S.
