

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, Mary Sentell of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said Mary Sentell, in and by J. W. My certain note or obligation, bearing the 22nd day of October 1926

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Two Hundred & Twenty Dollars (\$220.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 22nd day of October A. Dollars, \$12.00 Dollars, being the regular monthly installment payable on the 12 Shares of Stock, and \$8.00 Dollars, being the monthly interest on the advance of loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of \$12.00 Dollars, (\$12.00 Dollars, being the regular monthly payment on said stock and \$6.40 Dollars, being the monthly interest on balance due); for the next twenty months the sum of \$12.00 Dollars, (\$12.00 Dollars, being the regular monthly payment on said stock and \$4.80 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of \$12.00 Dollars, (\$12.00 Dollars, being the regular monthly payment on said shares of stock and \$3.60 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of \$12.00 Dollars, (\$12.00 Dollars, being the regular monthly payment on said shares of stock and \$1.60 Dollars, being the monthly interest on balance due.)

NOW, KNOW ALL MEN, That I the said Mary Sentell in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said Mary Sentell in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

Designated portion of Sans Soucy Highland as lot no. 37, on the northern side of Sunshine Avenue, in said Sans Soucy Highland, State and County aforesaid, described as follows:
Beginning at stake on the north side of Sunshine Avenue joint corner of lots nos. 34 and 35; and running thence with the joint line of said lots N. 67-00 W. 179 feet to an Alley thence with said Alley 50 feet in a northerly direction to a stake, thence S. 67-00 W. 185 feet to a stake on Sunshine Avenue; thence with Sunshine Avenue S. 22-30 W. 50 feet to the point of beginning, and being the same lot of land conveyed to me by H.
