Belue lands made by W.P. Morrow, Surveyor, on March 19, 1925 and having the following metes and bounds and courses and distances as shown on the said plat, to-wit: Lot No. 2: Beginning at a pin in road and in line with lot No. 1 and at corner of lot No. 3, and running thence along the line of lot No. 3, S. 57 W. 26.70 to a stake; thence N. 45 1/2 W. 9.25 to a stake in or near creek; thence along the meanders of creek or branch 10.40 chains to a stake; thence N. 67 E. 30.54 to iron pin at corner of lot No. 1 in road; thence along line of said road and along the line of lot No. 1, S. 40 E. 13.90 to the beginning corner and containing 45.19 acres, more or less, and being a part of the lands owned by the late T.M.
