

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That *Carrie Mary Morrow* of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, *Carrie Mary Morrow* in and by *myself* certain note or obligation, bearing the *13th* day of *October* 192*4*

*Carrie Mary Morrow* indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *thirty five hundred + no/100 (\$3500.00)* Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from *13th* day of *October* A. D. 192*4*, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

the said *Carrie Mary Morrow* shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *November* 192*4* and on the 20th or before the end of each month thereafter for twenty successive months the sum of *fifty eight + 33/100 (\$58.33)* Dollars, ( *\$5.00* Dollars, being the regular monthly installment payable on the *thirty five (35)* Shares of Stock, and *twenty three + 33/100 (\$23.33)* Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *fifty three + 67/100 (\$53.67)* Dollars, ( *\$35.00* Dollars, being the regular monthly payment on said stock, and *eighteen + 67/100 (\$18.67)* Dollars, being the monthly interest on balance due); for the next twenty months the sum of *forty nine + 20/100 (\$49.20)* Dollars, ( *\$35.00* Dollars, being the regular monthly payment on said stock and *fourteen + 20/100 (\$14.20)* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *forty four + 33/100 (\$44.33)* Dollars, ( *\$35.00* Dollars, being the regular monthly payment on said stock and *nine + 33/100 (\$9.33)* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *thirty nine + 67/100 (\$39.67)* Dollars, ( *\$35.00* Dollars, being the regular monthly payment on said shares of stock and *four + 67/100 (\$4.67)* Dollars, being the monthly interest on balance due);

Each of the above payments to be made on the 20th or before the last day of each month, and shall hereafter surrender to the Company the said *thirty five* shares of stock and the certificate thereof, the amount at such time said shares by *Carrie Mary Morrow* to be credited as a payment upon the advance or loan made, the said *Carrie Mary Morrow* and shall pay or cause to be paid all fines which may be duly imposed upon or charged against the said *Carrie Mary Morrow* in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That *Carrie Mary Morrow* in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to *myself* the said *Carrie Mary Morrow* in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

**Greenville Township, being lot No. 10 of Hillside Heights a subdivision of Tract No. 3 of the Overbrook Land. Beginning on Circle Street 305 feet from the right of way of the Greenville Traction Company at corner of Lot No. 11, and running thence S. 15-22 E. 73-2 feet to pin in the bend of the Street; thence S. 40-22 E. 72 feet to corner of lot No. 9; thence N. 38-50 E. 214.5 feet to corner of lots 7, 8, 9 and 11; thence S. 78-17 W. 204.6 feet to the beginning corner. The above described land is Lot No. 10 of Hillside Heights Subdivision of Tract No. 3 of the Overbrook Land, recorded in Plat Book F, page 101, R.M.C. Office for Greenville County.**
