provision shall not affect any discretion herein given to the Trustee to determine whether or not it shall take action hereunder without request of the noteholders, and without such indemnity. Each Trustee shall be entitled to reasonable compensation for any services by it rendered hereunder, and to reimbursement of all costs, expenses and liabilities by it paid or incurred, and it shall have a lien on all monies and property coming into its possession hereunder, which may be necessary to satisfy such compensation, expenses and liabilities.

6. That whenever there is a reference in the covenants and agreements herein contained, to any of the parties hereto, the same shall be construed to mean as well the heirs, legal representatives, successors and assigns (whether voluntary by act of the parties, or involuntary by operation of law) of the same. 7. IT IS UNDERSTOOD AND AGREED, That until default in the payment in one or more of the principal notes (1st or 2nd series) or interest coupon notes as they respectively mature, or default in the payment of any monthly installment as herein covenanted for, or the breach of one or more of the covenants and agreements of the said notes, or of this Deed of Trust, the first parties shall remain in quiet use, possession and management of said property, and in the employment of the income, revenue and profits therefrom. And that upon payment of all the principal and interest notes as they respectively mature, and the fulfillment and performance of all the covenants and agreements of the said notes, or of this Deed of Trust, then upon the request of, and at the cost of, the first parties, a proper release of this Deed of Trust shall be executed by either or both of the Trustees.
