



TOGETHER with, all and singular, the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging or in anywise incident or appertaining.
 TO HAVE AND TO HOLD, all and singular, the said Premises unto the said *Union Indemnity Co.* Heirs and Assigns, forever.  And the said Mortgagee, agree to insure the house and buildings on said lot in a sum not less than *Five hundred dollars* (in a company or companies satisfactory to the mortgagee), and keep the same insured from loss or damage by fire, and assign the policy of insurance to the said mortgagee, and that in the event that the mortgagee shall at any time fail to do so, then the said mortgagee may cause the same to be insured in his own name and reimburse the mortgagee for the premium and expense of such insurance under this mortgage, with interest.
