- And privilege is given to make additional payments of \$100.00 or any multiple thereof on the principal of said note at any interest payment date;

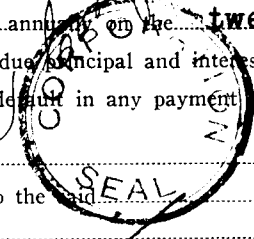
