WITNESSETH, Whereas, the said party of the first part is indebted to said MECHANICS BUILDING AND LOAN ASSOCIATION in the sum of

Dollars, money loaned this day, with interest thereon from this date at the rate of eight

per cent. per annum, payable weekly,

the payment whereof the said party of the first part is anxious to secure:

Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part all that certain piece, parcel and lot of land lying in Greenville County, in the State aforesaid, as follows, to-wit:

*in Greenville Township, near Monaghan Mill, about two miles west of Greenville Courthouse, and being a portion of a subdivision known as City View, and having the following meter and bounds:*

*Beginning at a stake on Hunt Street, 150 feet from the intersection of Hunt Street and Summit Street, at the joint corner of Lots nos 117 and 118, and running thence with the joint line of said lots in an easterly direction one hundred and twenty feet to a stake, joint corner of lots nos 117, 118, 117A and 118A; thence in a southerly direction 50 feet to the joint corner of lots 116, 117, 116A and 117A; thence with the joint line of lots 116 and 117 in a westerly direction 120 feet to a point on Hunt Street, which point is 100 feet from the intersection of Hunt and Summit Streets; thence with Hunt Street N. 10 E. 50 feet to the beginning corner, being Lot no 117 as shown on plat of City View as recorded in the R. M. C. Office for Greenville County in Plat Book A, page 460-461 and being the same lot conveyed to me by Ella Moody by deed not yet recorded.*
