

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, Louisa T. Headore of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, Louisa T. Headore in and by J. M. Ann certain note or obligation, bearing date the 29th day of June 1924

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of twenty-five hundred dollars (\$2500.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 29th day of June A. D. 1924

according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that the said Louisa T. Headore shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of July 1924

and on the 20th or before the end of each month thereafter for twenty successive months, the sum of \$29.17 Dollars, (\$12.50) Dollars, being the regular monthly installment payable on the twenty-five (25) Shares of Stock, and \$16.67 Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of \$25.83 Dollars, (\$12.50) Dollars, being the regular monthly payment on said stock and \$13.33 Dollars, being the monthly interest on balance due); for the next twenty months the sum of \$22.50 Dollars, (\$12.50) Dollars, being the regular monthly payment on said stock and \$10.00 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of \$19.17 Dollars, being the monthly payment on said shares of stock and \$10.00 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of \$15.83 Dollars, being the monthly payment on said shares of stock and \$10.00 Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said 25 shares of stock and the certificate thereof the amount at such time paid shares by me to be credited as a payment upon the advance or loan made I, the said Louisa T. Headore

and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against, I, the said Louisa T. Headore in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation and the condition thereunder written, reference being thereunto had will more fully appear.

NOW KNOW ALL MEN That I, Louisa T. Headore in consideration of the sum of money as aforesaid and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said Louisa T. Headore

in and truly had by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

PAID UP IN FULL
The City of Greenville, beginning at a stake corner of Poplar Avenue and Gasley Bridge Road, and running thence along said road N. 44 1/2 E. 59 feet to corner of lot No. 5; thence along line of lot No. 5, S. 40 1/2 E. 190 feet to a stake; thence in a parallel line with front line of said road fifty-nine (59) feet to said Poplar Avenue; thence along Poplar Avenue, N. 40 1/2 W. 190 feet to the beginning corner, being lot No. 6 on plat of sub-division of land formerly owned by F. K. Frazier and others made by W. A. Hudson June 20th 1905.

Also, all that other lot of land in the County and State aforesaid adjoining the above described lot and having the following metes and bounds, to-wit: Beginning at a stake corner of the above described lot and the Gasley Bridge Road; thence along said road about N. 44 1/2 E. 61 feet to stake on lot No. 4; thence in a southeast direction along lot No. 4 - 19 feet to a stake; thence in a southwest direction 61 feet to a stake on lot No. 6; thence along said lot, 90 feet to the beginning corner being known as Lot No. 5 in Plat aforesaid, and are the same lots of land conveyed to me by L. R. Henderson et al; heirs of W. F. Henderson, by their deed dated April 3rd, 1926, to be recorded.
