of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, *Gena McGee*, the said *Gena McGee* in and by *my* certain note or obligation, bearing date the *30th* day of *August* 192*6*

I am indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *Seven hundred fifty & no/100 (\$750.00)* Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the *30th* day of *August* A. D. 192*6*, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that *Gena McGee* the said *Gena McGee* shall pay or cause to be paid to the said

Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *September* 192*6*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *\$12.50*

Dollars, (*\$7.50*) Dollars, being the regular monthly installment payable on the *7 1/2* Shares of Stock, and *\$5.00*

Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *\$11.50* Dollars, (*\$7.50*)

Dollars, being the regular monthly payment on said stock and *\$4.00* Dollars, being the monthly interest on balance due); for the next twenty months the sum of *\$10.50* Dollars,

(*\$7.50*) Dollars, being the regular monthly payment on said stock and *\$3.00* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *\$9.50*

Dollars, (*\$7.50*) Dollars, being the monthly payment on said shares of stock and *\$2.00* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *\$8.50*

Dollars, (*\$7.50*) Dollars, being the monthly payment on said shares of stock and *\$1.00* Dollars, being the monthly interest on balance due.)

being a part of lot 514A of Block J according to a plat of a subdivision of land recorded in Plat Book C, Page 112 of the R. M. C. office for Greenville County. Said lot has a frontage of fifty (50) feet on a new street road and a depth of one hundred thirty two and one half (132 1/2) feet and is the same lot conveyed to me by a deed dated June 1st, 1922 and recorded in Deed Book 82, Page 2, R. M. C. office for Greenville County. Also: all those two lots in said Greenville Township, said County and State, being lots one and two (1 and 2) of Block D. of Summit View, a subdivision of land represented by a plat recorded in the R. M. C. office for said Greenville County in Plat Book A, Page 75 and conveyed to me by Bessie Rogers, by her deed of even date with these presents to be recorded.
