added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any
part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference
being thereunto had, as will more fully appear.)

bargain, sell and release unto the said Sunie A. Bramlett, all that piece, parcel or tract of land
containing eighty five (85) acres, more or less adjoining lands D.L. Johnson, J.Lee Green,
H.J. Southern, and others, being the same tract of land conveyed to me by John T. Bramlett
on the 19th, day of February recorded in Vol. 27, page 496, on the 20th, day of Feb. 1915.

Also, all that piece, parcel or tract of land containing sixty (60) acres, more or less
adjoining lands of H.J. Southern, J.P. Poole, R.F. Watson, D.L. Johnson, being the same
tract of land conveyed to me by R.F. Watson on the 23rd, day of December recorded in Vol.
