twenty-four and forty-one hundredths (24.41) acres, more or less, being the same tract of
land conveyed to me by W.T. Riddle by deed dated October 4, 1907, recorded in Vol. VVV,
page 599, as 46-1/2 acres, Less 22.1 acres conveyed by me to O.P. Mays by deed dated
December 20, 1917, recorded in Vol. 43, page 284.
