WHEREAS the First Parties have received a certain loan of money evidenced by the notes herein described and have agreed to secure the said notes by this Mortgage and Trust.

NOW THEREFORE THIS (DEED OF TRUST) MORTGAGE WITNESSETH: That in consideration of the sum of One Dollar (\$1.00) paid to the First Parties by the Second Parties, the receipt whereof is hereby acknowledged by the said First Parties and in consideration of the acceptance of the Second Parties of the trusts hereinafter set forth, which acceptance of the Second Parties is evidenced by their authentication of the said notes, the First Parties hereby grant and convey unto the Second Parties, their survivor and successors or successors, certain real estate situated in the County of Greenville, State of South Caro-

lina, and described as follows, that is to say; All that certain piece, parcel or lot of land, situate, lying and being in the State and County aforesaid, just without the corporate limits of the City of Greenville, being known and designated on a plat of the O.P. Mills property as Lot No. 8, in Block K, said plat being recorded in the R.M.C. Office for Greenville County, in Plat Book F, page 171, and having according to a survey made by Dalton & Neves, July, 1926, the following metes and bounds, to-wit:
