of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:  
WHEREAS, *J. S. Hunter*, the said

in and by *my* certain note or obligation, bearing date the *23rd* day of *April* 192*7*

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *Thirty-Eight Hundred and no/100* Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the *23rd* day of *April* A. D. 192*7*, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

*J. S. Hunter* the said shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the *20th* or before the end of the month of *May* 192*7*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of

*Sixty-Three and 34/100* Dollars, (*Thirty-Eight and 20/100* Dollars, being the regular monthly installment payable on the *Thirty-eight* Shares of Stock and *Twenty-Six and 34/100* Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *Fifty-Eight and 26/100* Dollars, (*Thirty-eight* Dollars, being the regular monthly payment on said stock and *Twenty and 26/100* Dollars, being the monthly interest on balance due);

for the next twenty months the sum of *Fifty-Three and 20/100* Dollars, (*Thirty-Eight* Dollars, being the regular monthly payment on said stock and *Fifteen and 20/100* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Forty-Eight and 14/100* Dollars, (*Thirty-Eight* Dollars, being the monthly payment on said shares of stock and *Ten and 14/100* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Forty-Three and 09/100* Dollars, (*Thirty-eight* Dollars, being the monthly payment on said shares of stock and *Five and 09/100* Dollars, being the monthly interest on balance due.)

NOW, KNOW ALL MEN that *J. S. Hunter* the said, in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars

Hunter* in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the signing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, conveyed, sold and released, and by these Presents do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land situated in the County of Greenville, State of South Carolina, and described as follows:

In the City of Greenville, beginning at a point on the east side of *M. C. See Street*, 181 1/4 feet northwest of East Avenue, and running thence *N. 21-45 W. 63* feet to a corner; thence *S. 80-15 W. 150* feet to a point on *M. C. See Street*; thence *S. 21-45 E. 60 1/2* feet to the beginning corner; and

Being a portion of the land conveyed to me by quit claim deed of *Herry P. M. C. See* dated April 22, 1927; and

Being a portion of the land conveyed to me, together with other land, by several deeds executed by *H. P. M. C. See* and *E. B. and E. E. Jones*.
