L. L. Taylor
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:
WHEREAS, *L. L. Taylor*, the said *L. L. Taylor*
in and by *my* certain note or obligation, bearing date the *7th* day of *June* 192*7*
indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate,
duly incorporated under the laws of such State), in the sum of *One Thousand and no/100* Dollars,
with interest thereon at the rate of eight per centum per annum, payable monthly, from the *7th* day of *June* A. D. 192*7*,
according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that
the said *L. L. Taylor* shall pay or cause to be paid to the said
Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *June*
192*7*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *Sixteen and*
67/100 Dollars, (*Ten* Dollars, being the regular monthly installment payable on the *Ten* Shares of Stock, and *Six and 67/100*
Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the
sum of *Fifteen and 33/100* Dollars, (*Ten* Dollars, being the regular monthly payment on said stock and *Five and 33/100* Dollars, being the monthly interest on balance due);
for the next twenty months the sum of *Fourteen and 70/100* Dollars,
(*Ten* Dollars, being the regular monthly payment on said stock and *Four and 70/100*
Dollars, being the monthly interest on balance due) for the next twenty months pay the sum of *Twelve and 67/100*
Dollars, (*Ten* Dollars, being the monthly payment on said shares of stock and
Two and 67/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the
sum of *Eleven and 33/100* Dollars, (*Ten* Dollars, being the monthly payment on said shares of stock and
