

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, L. A. Hamilton  
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:  
WHEREAS, I, the said L. A. Hamilton  
in and by my certain note or obligation, bearing date the 9th day of June 1927  
indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate,  
duly incorporated under the laws of such State), in the sum of Twenty four hundred and no/100 Dollars,  
with interest thereon at the rate of eight per centum per annum, payable monthly, from the 9th day of June A. D. 1927,  
according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I  
the said L. A. Hamilton shall pay or cause to be paid to the said  
Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of June  
1927, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of forty and 20/100  
Dollars, (Twenty-four Dollars,  
being the regular monthly installment payable on the twenty-four Shares of Stock, and Sixteen and 20/100  
Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the  
sum of thirty-six and 80/100 Dollars, (twenty-four  
Dollars, being the regular monthly payment of said stock and twelve & 80/100 Dollars, being the monthly interest on balance due);  
for the next twenty months the sum of thirty-three and 60/100 Dollars,  
(twenty-four Dollars, being the regular monthly payment of said stock and nine and 60/100  
Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of thirty & 40/100  
Dollars, (twenty-four Dollars, being the monthly payment on said shares of stock and six and 40/100  
Dollars, being the monthly interest on balance due); for the next twenty months pay the  
sum of twenty-seven & 20/100 Dollars, (twenty-four Dollars, being the monthly payment on said shares of stock and three and 20/100  
Dollars, being the monthly interest on balance due.)  
Each of the above payments to be made on the 20th or before the last day of each month, and thereafter, surrender to the Company the said 24  
shares of stock and the certificate therefor, the amount at such time paid shares to be credited as a payment upon the advance or loan made me  
L. A. Hamilton and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against, the said L. A. Hamilton  
in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the  
said note or obligation, and the condition hereunder written, reference being thereunto had will more fully appear.  
NOW, KNOW ALL MEN, That I, the said L. A. Hamilton  
in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company,  
according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me  
the said L. A. Hamilton  
in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is  
hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and  
Trust Company, all that tract or parcel of land situated in the County of Greenville, State of South Carolina, and described as follows:

"All that piece, parcel or lot of land in ward 2 of  
the City of Greenville, on the north side of Stone  
Avenue and being lot no 12, of section "4" of a plat  
of Stone Land Company said plat recorded in  
R. M. C. Office of Greenville in Plat Book "A" page  
337-345.  
Said lot having a frontage on Stone Ave. of sixty (60)  
feet with a depth of about one hundred and thirty  
five feet and being the lot deeded to me by Charlotte  
Tripp on May 28th, 1920,  
Being some lot of land conveyed to me by Thos. H.  
Fowler, deed dated July 6, 1922, and recorded in Book  
75, page 223, in the R. M. C. Office for Greenville  
County"
