R. F. Griffin
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:
WHEREAS, *I*, the said *R. F. Griffin*
in and by *my* certain note or obligation, bearing date the *4th* day of *October* 192*7*
indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate,
duly incorporated under the laws of such State), in the sum of *Nine hundred and no/100 900 00* Dollars,
with interest thereon at the rate of eight per centum per annum, payable monthly, from the *4th* day of *October* A. D. 192*7*,

Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the
sum of *Thirteen and 80/100* Dollars, (*Nine*
Dollars, being the regular monthly payment on said stock and *Four and 80/100* Dollars, being the monthly interest on balance due);
for the next twenty months the sum of *Twelve and 60/100* Dollars,
(*Nine* Dollars, being the regular monthly payment on said stock and *Three and 60/100*
Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Eleven and 40/100*
Dollars, (*Nine* Dollars, being the monthly payment on said shares of stock and
Two and 40/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the
sum of *Ten and 20/100* Dollars, (*Nine* Dollars, being the
monthly payment on said shares of stock and *One and 20/100* Dollars, being the monthly interest on balance due.)

in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company,
according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to *me*

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is
hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and
Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In the City of Greenville, being lot No. 5, according to plat recorded in Plat Book A, page 547, R. M. C. Office for said county; Beginning at a stake 208 feet from Rock line on North side of Burke Street, and running thence along said Street S. 59-30 E. 52 feet to corner of lot No. 6; thence N. 30-30 E. 147 feet; thence N. 39 1/2 W. 55 feet thence S. 30-30 W. 166 feet to the beginning corner; and Being the same lot conveyed to me by deed recorded in the office aforesaid in Deed Book 59, page 3.
