TO ALL WHOM THESE PRESENTS MAY CONCERN:

of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, William Robertson, the said William Robertson in and by me certain note or obligation, bearing date the 7th day of May 1928

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of six hundred (\$600.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 7th day of May A. D. 1928, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

the said William Robertson shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of March 1929, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of six (\$6.00) Dollars, being the regular monthly installment payable on the six (\$600.00) Shares of Stock, and three (\$3.50) Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of eight (\$8.10) Dollars, being the regular monthly payment on said stock and six (\$6.00) Dollars, being the monthly interest on balance due); for the next twenty months the sum of eight (\$8.10) Dollars, being the regular monthly payment on said stock and six (\$6.00) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of one (\$1.00) Dollars, being the monthly payment on said shares of stock and seven (\$7.00) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of six (\$6.00) Dollars, being the monthly payment on said shares of stock and seven (\$7.00) Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said six (\$6.00) shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made me the said William Robertson

and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against me the said William Robertson in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation and the conditions hereunder written, reference being thereunto had with more fully appear.

NOW KNOW ALL MEN that William Robertson the said William Robertson in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me

the said William Robertson in that well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

Situate in the city of Greenville, County and State of aforesaid, being Lot no. 33, according to a plat of West End Land and Improvement Company recorded in Plat Book A, page 15-3, and conveyed to said William Robertson by said West End Land and Improvement Company by deed dated July 24, 1915, and recorded in Deed Book 15, page 372, R. M. C. Office for said Greenville County. Said Lot has the following meters and bounds, beginning on the East side of Chiesra Avenue at the corner of lot no. 32, thence running N. 79 E. 15-0 feet to corner of lot no. 33; thence N. 11 W. 5-0 feet to corner of lot no. 34; thence S. 79 W. 15-0 feet to Chiesra Avenue; thence with Chiesra Avenue S. 11 E. 15-0 feet to the beginning corner.
