I, **Lettie Fields**

SEND GREETING:

WHEREAS, **I**, the said **Lettie Fields**
in and by **my** certain **promissory** note in writing, of
even date with these presents, **am** well and truly indebted to
Tom Harrison
in the full and just sum of **Five thousand**
Dollars, to be paid **three years from date**

with interest thereon, from **date** at the rate of **seven** per cent. per annum, to be
computed and paid **annually**

until paid in full, all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal
or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; and note further providing for an attorney's fee of

ten per cent of the amount due besides all costs and expenses of collection to be
added to the amount due on said note to be collected as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any
part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference being
thereunto had, will more fully appear.)

NOW ALSO, That **I**, the said **Lettie Fields**
in consideration of the said **five** and sum of money aforesaid, and for the better securing the payment thereof to the said

Tom Harrison
according to the terms of said note, and also in consideration of the further sum of Three Dollars, to **me**, the said
Lettie Fields

in hand well and truly paid by the said
Tom Harrison

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant,

bargain, sell and release unto the said **Tom Harrison**, that certain lot of land situate in the City and
County of Greenville, and being a portion of Boyce's Addition And having the following
metes and bounds according to a plat recorded in Plat Book A, at page 179: Commencing at
an iron pin south side of North Street joint corners of lots numbers 3 and 4; thence S.
15-0 E. 126 ft. and 1 inch to iron pin on a ten foot alley; thence N. 76-15 E. along said
alley 66 ft. 8 in. to an iron pin joint corner of lots 4 and 5; thence N. 15-0 W. along line
of said lots 126 ft. and 1 in. to iron pin on North Street; thence S. 76-45 W. 66 ft. and
8 in. to the beginning corner.

This being the lot this day conveyed to me by L.A. Mills, my said deed to be recorded. This
mortgage being junior to one assumed by me on said lot in the sum of Five Thousand Dollars.
