SEND GREETING:

WHEREAS, I, the said Paul E. Cass
in and by my certain promissory note in writing, of
even date with these presents, am well and truly indebted to

W. D. Reaves

in the full and just sum of nine hundred (\$900.00)
Dollars, to be paid ninety days after date

with interest thereon, from maturity computed and paid at the rate of 8 per cent. per annum, to be

computed and paid until paid in full all interest not paid when due to bear interest at the same rate as principal; and if any portion of
principal or interest be at any time past due and unpaid then the whole amount evidenced by said note to become immediately due at the option of the holder
hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of

10% of amount due besides all costs and expenses of collection to be
added to the amount due on said note to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or
any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which are secured under this mortgage; as in and by the said note,
reference being thereunto had, as will more fully appear.)

NOW, KNOW ALL MEN, That the said Paul E. Cass
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

according to the terms of said note, and also in consideration of the further sum of Three Dollars, to me, the said

Paul E. Cass in hand well and truly paid by the said W. D. Reaves

and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do
grant, bargain, sell and release unto the said W. D. Reaves

of those two piece, parcels or lots of land
in Greenville Township, Greenville County, State
of South Carolina, known and designated as
lots 92 and 93 of the subdivision known as
Mountain View Land Company, according to
plat recorded in Plat Book "A" at page 396
and having the following, notes and bounds
to wit: Beginning at an iron pin on East
side of Chandler Street corner of lot 94
and running thence with line of lot 94, S. 89 1/2 E.
148 feet to after foot alley; thence with said
alley, N. 11 1/2 W. 100 feet, to corner of lot 91; thence
with line of lot 91, N. 89 1/2 W. 109 1/2 feet to Greene Street
thence with Greene Street, S. 35 25 W. 50 feet to
Chandler Street; thence with Chandler Street
S. 11 1/2 E. 55 feet to the beginning corner. Being
