

AGREEMENT FOR EXTENSION OF LOAN NO. 105775

hereby agree S. to pay the principal sum remaining due as aforesaid as follows: on the first day of each month, beginning on the first day of August, 1928, the sum of Thirty (\$30.00) Dollars, to be applied on the Principal of said amount due on said note, and also, at the same times, interest at the rate of Six (6%) Per Cent, Per Annum, on the balances of said Principal remaining due thereon on the said first day of the month, and on the first day of July, 1933, the balance of said Principal sum with interest thereon

with interest thereon from _____, 19____, to _____, 19____, at the rate of _____ per cent per annum, payable _____ annually; and with interest after maturity as set forth in said note. additional Payments of not

PREPAYMENT PRIVILEGE: less than one hundred dollars (\$100) at any one Payment, in multiples of the monthly instalment of Principal, may be made on the Principal at any interest - Payment date, and the amount so Paid shall be credited on said Principal.

And the parties to this agreement hereby consent to said extension and agree that said mortgage

shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
