hereby agree **s** to pay the principal sum remaining due as aforesaid as follows: **On the first day of each month, beginning on on the first day of December, 1, 1926, the sum of Twenty (\$20.00) dollars to be applied on the principal of said amount due on said note, and also, at the same times, interest at the rate of six (6%) per cent. per annum of the balances of said principal remaining due thereon on the said first day of each month, and on the first day of November 1931, the balance of said principal sum with interest thereon; and with interest after maturity as set forth in said note. Additional payments of not less than One Hundred Dollars (\$100) at any one payment, in multiples of the monthly instalment of principal, may be made on the principal at any interest-payment date, and the amount so paid shall be credited on said principal**
with interest thereon from _____ to _____ at the rate of _____ per cent. per annum, and with interest after maturity as set forth in said note.
