

AGREEMENT FOR EXTENSION OF LOAN NO. 164996

WHEREAS, there remains unpaid on a certain note executed and delivered by L. C. Good to The Prudential Insurance Company of America, secured by a mortgage upon real estate in Greenville County, South Carolina, dated November 23, 1925, and recorded in said County on November 23rd, 1925, in Volume 171 of mortgages on Page 4, in the sum of Seventy-Two Hundred (\$7,200.00) Dollars, with interest from November 23rd, 1925, and,

WHEREAS, title to the mortgaged premises is now vested in L. C. Good subject to said mortgage and,

WHEREAS, the said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, the said L. C. Good hereby agrees to pay the principal sum remaining due as aforesaid as follows:

Two Hundred (\$200.00) dollars on November 23, 1931; Two Hundred (\$200.00) dollars on November 23, 1932; Two Hundred (\$200.00) dollars on November 23, 1933; Two Hundred (\$200.00) dollars on November 23, 1934 and the balance of Sixty Four Hundred (\$6,400.00) dollars on November 23, 1935; with interest thereon from November 23, 1930, to November 23, 1935, at the rate of five and one-half cent per annum, payable semi-annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Privilege is given to make additional payments on the principal sum of said note in sums of one hundred (\$100.00) dollars or multiples thereof, on any interest maturity date.

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
