SEND GREETING:

WHEREAS, I, *Homer S. Norris*, the said *Homer S. Norris*
in and by *my* certain *promissory* note in writing, of
even date with these presents, *am* well and truly indebted to
V. M. Babb

in the full and just sum of *Sixty 2 no 100*
Dollars, to be paid *on or by the first day of July 1928*

with interest thereon, from *date* at the rate of *4* per cent. per annum to be
computed and paid *annually in advance*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *Twenty-Five Dollars*

besides all costs and expenses of collection, to be
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being
thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I, *Homer S. Norris* the said *Homer S. Norris*

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *V. M. Babb*

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *me*, the said *Homer S. Norris*

in hand well and truly paid by the said *V. M. Babb*

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bar-
gain, sell and release unto the said *V. M. Babb* his heirs and assigns

*all those two piece parcels or lots of land
lying being and situate in the town of
Mountain Dam and in the County and State
aforesaid, known as lots nos. 29 & 30 in Block 2
of the Subdivision of the lands of the Mountain
Dam Manufacturing Company said being the
same lots conveyed to my mother S. C. Norris by
deed of P. M. La Roy, said deed being recorded
in the R. M. C. Office for Greenville, County, in
Deed Book 888 at page 5-5-8 to, which reference
is made for a fuller description, as to lines
distances, corners, etc. The above lots are situated
on the north side of Sharp Street, my interest
therein being a undivided part thereof, being
devised through the will of my mother S. C.
Norris, deceased; said will being duly recorded
in the Probate Judge's Office for Greenville
County.*
