computed and paid *quarterly*

until paid in full; all interest not paid when due to bear interest at the same rate as principal, and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *19 1/2* per cent of
amount due besides all costs and expenses of collection, to be
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being
thereunto had, as will more fully appear.

gain, sell and release unto the said *Elizabeth A. White, her heirs and assigns, All that piece, parcel or*

lot of land in Greenville Township, Greenville County, State of South Carolina, near the limits
of the City of Greenville, in the suburb known as Highland Terrace, and having the following
metes and bounds: Beginning at an iron pin at the intersection of Main Street and Hillcrest
Drive, and runs thence S. 66-30 E. 110 feet to an iron pin, corner of lot No. 16; thence S.
23-30 W. 190 feet to a 10 foot alley; thence along said alley N. 66-30 W. 97.7 feet to an
iron pin on Main Street; thence with said Street N. 19-47 E. 190.4 feet to the beginning corner
