of Greenville, in the County of Greenville, and the State of South Carolina, and Greeting:

WHEREAS, J. H. Pittman, the said J. H. Pittman
 in and by my certain note or obligation, bearing date the 13th day of December 1928
 indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly
 incorporated under the laws of such State), in the sum of Fifteen Hundred (\$1500.00) Dollars,
 with interest thereon at the rate of eight per centum per annum, payable monthly, from the 13th day of December A. D. 1928

 Dollars, (15.00 Dollars, being the regular monthly installment payable on the fifty Shares of Stock, and eight + 75/100 (\$8.75)
 Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of
Twenty-two (\$22.00) Dollars, being the regular monthly payment on said stock and seven (\$7.00) Dollars, being the monthly interest on balance due);
 for the next twenty months the sum of Twenty + 25/100 (\$20.25) Dollars, being the regular monthly payment on said stock and five + 25/100 (\$5.25)
 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Eighteen + 50/100 (\$18.50)
 Dollars, being the regular monthly payment on said shares of stock and three + 34/100 (\$3.50) Dollars, being the monthly interest on balance due); for the next twenty months pay
 the sum of Sixteen + 15/100 (\$16.75) Dollars, being the regular monthly payment on said shares of stock and one + 15/100 (\$1.75) Dollars, being the monthly interest on balance due.)

 acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company,
 all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

Lying in Greenville Township, State and County aforesaid
 on the south side of Grove Road, and having the fol-
 lowing metes and bounds,
 Beginning at an iron pin, as a corner, 300 feet from
 the west side of Augusta Street, thence running along
 the south side of Grove Road N. 45-27 W. 60 feet; thence
 approximately parallel with Augusta Street S. 47-52 E.
 170 feet; thence parallel with Grove Road N. 45-27 E. 60
 feet; thence N. 47-52 W. 180 feet to beginning corner, be-
