I, Mrs. M. E. Sudduth of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, Mrs. M. E. Sudduth, the said my certain note or obligation, bearing date the 4th day of January 1929

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Two Hundred (\$200.00) Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 4th day of January A. D. 1929 according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I, Mrs. M. E. Sudduth

the said Mrs. M. E. Sudduth shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of January 1929, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of

Three + 17/100 (\$3.17) Dollars, (\$2.00) Dollars, being the regular monthly installment payable on the Two (2) Shares of Stock, and One + 17/100 (\$1.17) Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of

Two + 93/100 (\$2.93) Dollars, (\$2.00) Dollars, being the regular monthly payment on said stock and (.93) Dollars, being the monthly interest on balance due); for the next twenty months the sum of

Two + 70/100 (\$2.70) Dollars, (\$2.00) Dollars, being the regular monthly payment on said stock and 70/100 (\$.70) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of

Two + 47/100 (\$2.47) Dollars, (\$2.00) Dollars, being the regular monthly payment on said stock and 47/100 (\$.47) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of

Two + 23/100 (\$2.23) Dollars, (\$2.00) Dollars, being the regular monthly payment on said stock and 23/100 (\$.23) Dollars, being the monthly interest on balance due.) Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said two shares of stock and the certificate thereof, the amount of such time paid shares by me to be credited as a payment upon the advance or loan made by the said

Mrs. M. E. Sudduth and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against me, the said Mrs. M. E. Sudduth

in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had with more fully appear.

NOW, KNOW ALL MEN, That I, Mrs. M. E. Sudduth in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me

the said Mrs. M. E. Sudduth in hand well and truly paid by the said The Carolina Loan and Trust Company, and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

All those two certain lots of land situate, just outside of the City limits of Greenville, in the subdivision known as Norwood Heights, and being designated as Lot Nos. 1 and 2 in Block F, as shown on a plat made by W.D. Neves, Engineer, the said plat being recorded in the R.M.C. Office for Greenville County in Plat Book E, at pages 215 and 216, and each lot having a frontage of twenty-five (25) feet on Main Street and a depth of one hundred fifty (150) feet, being a portion of the land conveyed to me, Mrs. M.E. Sudduth by P.C. Sudduth, in April 1922, by deed recorded in Volume 73, at page 592, said R.M.C. Office for Greenville County".
