WHEREAS, *D.A. Bishop*, the said *D.A. Bishop* in and by *my* certain note or obligation, bearing date the *22nd* day of *June* 192*9*

jam indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *Eighteen hundred fifty (\$1,850.00)* Dollars, with interest thereon at the rate of *seven* per centum per annum payable monthly, from the *Twenty-second* day of *June* A. D. 192*9*

according to the provisions of the Charter, By-Laws, Rules and Regulations, of the said Company, in manner and form following, that is to say, that *D.A. Bishop* the said *D.A. Bishop* shall pay or cause to be paid to the said

Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *July* 192*9*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *Twenty-seven & 13/100 (\$27.13)* Dollars, (*\$18.50* Dollars, being the regular monthly installment payable on the *eighteen & 50/100 (\$185.00)* Shares of Stock, and *Seven & 13/100 (\$7.13)* Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *Twenty-seven & 13/100 (\$27.13)* Dollars, (*\$18.50* Dollars, being the regular monthly payment on said stock and *Eight & 63/100 (\$8.63)* Dollars, being the monthly interest on balance due);

for the next twenty months the sum of *Twenty-seven & 13/100 (\$27.13)* Dollars, (*\$18.50* Dollars, being the regular monthly payment on said stock and *Six & 47/100 (\$6.47)* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Twenty-seven & 13/100 (\$27.13)* Dollars, (*\$18.50* Dollars, being the regular monthly payment on said shares of stock and *Four & 32/100 (\$4.32)* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Twenty & 66/100 (\$20.66)* Dollars, (*\$18.50* Dollars, being the regular monthly payment on said shares of stock and *Two & 16/100 (\$2.16)* Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said *18 1/2* shares of stock and the certificate thereof, the amount at such time paid shares by *me* to be credited as a payment upon the advance or loan made *me*, the said

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

Situated northwest of the City of Greenville Township, County and State aforesaid, on the west side of Franklin Road and being a portion of the tract of land known as Hillwood Tract, and having the following metes and bounds:

Beginning at the corner of Lot No. 63, and running thence along the west side of Franklin Road N. 46-03 E. 60 feet to the corner of Lot No. 65; thence N. 44 W. 350 feet to an iron pin; thence S. 46-03 W. 60 feet to the corner of Lot No. 63; thence along the north side of that lot 350 feet, more or less, to the beginning corner, and being known and designated as Lot No. 64, and being the same lot conveyed to D. A. Bishop by W. J. Thackeron May 11, 1925, has been recorded in the R. M. C. Office for Greenville County in Volume 105, page 328.
