TO ALL WHOM THESE PRESENTS MAY CONCERN:

of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, Emma Huff, the said Emma Huff in and by my certain note or obligation, bearing date the 27th day of November 1929

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Twelve Hundred (\$1200.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 27th day of November A.D. 1929 according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

the said Emma Huff shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, of Greenville City aforesaid, monthly, on the 20th or before the end of the month of December 1929, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Nineteen (\$19.00) Dollars,

(.42.00) Dollars, being the regular monthly installment payable on the Shares of Stock, and Seven (\$7.00) Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Seventeen (\$17.00) Dollars, (.42.00) Dollars, being the regular monthly payment on said stock and 6% (.60) Dollars, being the monthly interest on balance due);

for the next twenty months the sum of Fourteen (\$14.00) Dollars, being the regular monthly payment on said stock and 2% (.20) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Fourteen & 8% (.80) Dollars, being the monthly payment on said shares of stock and

Two & 8% (.80) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Thirteen & 3% (.30) Dollars, being the monthly payment on said shares of stock and

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereupon surrender to the Company the said twelve shares of stock and the certificate thereof, the amount at such time paid shares by me to be made as a payment upon the advance or loan made me the said Emma Huff

and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against, me the said Emma Huff in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That Emma Huff, the said Emma Huff in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said Emma Huff

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

All that certain lot of land in Greenville Township, Greenville County, South Carolina on the west side of Henderson Street, located in Block 46, between new-cut road and O'Neal Street, and being lot no 84 according to a plat of City View recorded in Plat Book A, page 460 R. M. Co. Office for Greenville County.

Said lot has a frontage of fifty (50) feet on Henderson Street and a depth of one hundred fifty (150) feet, running back to an alley; There is a new five-room house located on this lot, and this money is borrowed for the purpose of paying the costs of the material used in its construction.

This is one of the lots conveyed to Emma Huff by C. F. Huff by deed dated April 1928, recorded May 19, 1928, in Deed Book 109, page 400, R. M. Co. office for Greenville County.
