with interest thereon, from the day of recording, or payment, whichever comes first, until paid in full all interest not paid when due to bear interest at the same rate as principal; and, if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note, to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of 10%.
